Church's Auxiliary for Social Action (CASA), a national level voluntary organisation, having 68 years of experience in responding to emergencies and disasters in India, has stepped in to provide immediate relief and help to the victims of the devastating series of earthquakes in Nepal ever since the noon of April 25<sup>th</sup> that has killed over 7,000 and left more than 12,000 injured and homeless. The apprehension is, however, that the death toll may rise to 10,000 or so.

In its immediate relief phase:

- CASA intends to support 5,000 families affected by the earthquake.
- This number is for the immediate relief phase only and will cover the activities namely food support, non-food items, temporary shelter (tarpaulins) and hygiene kits to meet the immediate needs.
- Initial estimated budget for this immediate relief intervention is Rs. 4crores.
- CASA has already deployed two experienced staff with our network in Nepal. The second lot of human resource personnel along with the vehicle has left on May 02<sup>nd</sup>, 2015; and five more staff will be deployed to support the network to undertake real-time humanitarian aid and psychosocial support to the affected families in Nepal.
